State charter school board members and administrators are required by law to attend the SCSC School Governance Training. Topics will include the roles and responsibilities of school board members and administrators, ethics, school funding and budgets, audit requirements, strategic planning and succession planning, among others. ## Charter Schools Financial Management Certification Program

#### Introductory Accounting February 25-27, 2014 Atlanta, Georgia Invited: School Business Managers and Administrators

The SCSC will offer a full scholarship to state charter business managers and/or administrators who wish to enroll in the Carl Vinson Institute of Government's Charter Schools Financial Management Certification Program. Courses must be completed within a three-year period. The Introductory Accounting course will introduce participants to basic accounting concepts for governmental funds. Topics covered include – accounting equation, chart of accounts, double entry accounting, accounting systems and records, fund accounting, basis of accounting, payroll and benefit accounting, and case study. ### Federal Grant Asset Redistribution Opportunity

The SCSC on behalf of the Georgia Department of Education (GaDOE) must redistribute assets purchased by Scholars Academy Charter School using federal Charter School Program (CSP) grant funding following the school's closure at the conclusion of the 2014 Fiscal Year. Charter schools that are operating in Georgia in the 2014-2015 school year or have a charter approved by the State Board of Education to operate in the 2015-2016 school year by the application deadline may apply to receive, at no cost, furniture and equipment previously used by Scholars Academy Charter School. The application and equipment inventory is available on the SCSC website under the Grant Opportunities and Resources tab here. The deadline to submit applications is January 31, 2015.

### 2014 CCRPI Reports

The Georgia Department of Education (GaDOE) has released the College and Career Ready Performance Index (CCRPI), based on data from the 2013-2014 school year. The CCRPI is Georgia's statewide accountability system, implemented in

2012 to replace the No Child Left Behind (NCLB) Adequate Yearly Progress (AYP) measurement, after the U.S. Department of Education granted Georgia's waiver from NCLB. It measures schools and school districts on a 100-point scale, helping parents and the public better understand how schools are performing in a more comprehensive manner than the pass/fail system previously in place under AYP.

### **Charter Accountability: Georgia Milestones Assessment**

At the November 2014 SCSC meeting, commissioners agreed that staff should issue an administrative clarification to amend all existing charter contracts by replacing any references to CRCT or EOCT with references to Georgia Milestone Assessments (GMA). In other words, because all material aspects of state charter school contracts remain valid, the SCSC will issue an administrative clarification for each school that clarifies the change in the name of the state assessments. The 2014-15 Georgia Milestones results will count for charter school accountability.

The administration of the GMA will not detrimentally impact state charter school accountability because the SCSC does not set specific performance thresholds for the schools it authorizes. Rather, state charter school contracts simply require SCSC authorized schools to outperform the traditional school districts located within their respective attendance zones. Because state charter school performance on state standardized assessments is always examined relative to the performance of other schools within their attendance zone (rather than by 'absolute bar' performance metrics), the existing charter contract goals account for any performance dips (or spikes) *caused by the assessment*.

Additionally, the SCSC also conducts a value-add analysis which examines the performance of state charter schools while controlling for their unique student characteristics. Because the value-add analysis uses a statewide data set, it allows the SCSC to fairly compare state charter schools to the district(s) they serve by controlling for key demographics and indicators. In other words, the value-add analysis tells us how the school's *predicted* performance compares to its *actual* performance (given its unique student population) relative to the district(s) it serves. This type of analysis is stable regardless of any potential performance fluctuations that result from the administration of a new state assessment.

### **Proposed English Language Arts and Mathematics Standards**

The Common Core Georgia Performance Standards (CCGPS) in English Language Arts (ELA) and Mathematics have been revised based on a formal review and evaluation process as directed by an Executive Order from the Governor. The review and evaluation process included several survey opportunities as well as legislative and Georgia State Board of Education listening sessions. Survey feedback was collected and analyzed by the University System of Georgia. The University System of Georgia provided survey results and recommendations for revisions to the standards to the State Board of Education on September 24, 2014.

A Working Committee representing K-12 Georgia public school teachers, post-secondary staff, parents, and instructional leaders from across the state made revisions to the standards based on public feedback and recommendations from survey results for standards with less than 90% approval. ELA and Mathematics Advisory Committees then reviewed the recommended changes made by the Working Committees and provided additional suggestions for clarity and change based on feedback and survey recommendations. Business and Industry partners that include the Georgia Chamber of Commerce, Metro Atlanta Chamber of Commerce, Georgia Partnership for Excellence in Education, Georgia Public Broadcasting, and Georgia Power have been involved in the review and evaluation process. An Academic Review Committee consisting of representatives from the writing and advisory committees; the Governor's Office of Student Achievement; and the Georgia Department of Education leadership staff reviewed and finalized the draft revised standards for presentation to the State Board of Education for permission to post for 60 days of public review and comment.

The survey will be posted for 60 days of public review and comment from **November 12, 2014, through January 10, 2015**. The draft revised standards and public feedback will be presented to the Georgia State Board of Education on January 15, 2015, for approval.

### **Student Learning Objectives**

The GaDOE has released the revised <u>Student Learning Objective (SLO) Attainment Rubric</u>. This rubric reflects revisions in the Level II, Level III, and Level IV categories. The SLO rubric will be utilized to determine student growth in non-tested subjects during **SY 2014-2015**. Recommendations from the Technical Advisory Committee (TAC), the Student Learning Objective Advisory Committee, as well as additional SLO data information were taken into consideration during the revision process.

Additionally, GaDOE will offer a SLO State Trainer Credentialing opportunity for interested Georgia educators. This will be the fifth cohort organized this year. To become a state credentialed trainer, participants must attend all three days of training, conduct supervised SLO trainings and successfully complete the SLO credentialing assessment. Participants will receive in depth training focused on the SLO process. GaDOE trainers will address setting realistic growth targets, developing SLO statements, as well as developing or selecting sound assessments used to measure student growth and evaluate teachers.

The 3 day training will be conducted at GaDOE on January 21-23, 2015. The sessions will be held from 8:30 AM to 4:30 PM daily. Travel and per diem meal costs will be reimbursed.

### Increasing Access to Advanced Placement Courses

The GaDOE is encouraging schools to increase access to Advanced Placement (AP) courses and exams. The AP program enables students to take college-level courses and exams and earn college credit while still in high school. Georgia is ranked 12<sup>th</sup> nationwide for the largest percentage of high school graduates succeeding on at least one AP exam during high school.

School leaders may identify students with *AP Potential*, i.e., students who show potential to succeed in AP course work, by utilizing results from the fall 2014 PSAT exam. Research studies by The College Board indicate that PSAT scores are strong predictors of students' AP exam scores when used in conjunction with high school grades and previous course work in the same discipline. PSAT scores can provide reliable guidance in identifying additional students who may be ready for the rigor of AP. Data shows that over 20,000 Georgia students with *AP Potential* are not being served in AP courses.

First-time users will be asked to create an educator's professional account and enter their AP Potential access code. Access codes appear on the PSAT Roster of Scores mailed to high school principals in December. The use of AP Potential will enable school staffs analyze 2014 PSAT data, recognize students with potential for success in AP courses, and help identify new AP courses to offer that might best meet the needs and potential of your students.

### **GaDOE School Climate Survey**

School climate surveys for the 2014-2015 school year are now available. Data from the **Georgia Student Health Survey 2.0**, the **Georgia School Personnel Survey** and the **Georgia Parent Survey**, along with other sources, will be used in the calculation of a **School Climate Star Rating** which is a diagnostic tool within the CCRPI. Each of the surveys is administered online through the provided URL address. As soon as the school administrator enters the URL address into the web browser, a drop-down menu will appear and the school administrator will use the drop-down menu to select their school district and their school. If there are new schools that wish to participate that are not included in the drop-down menu, please contact GaDOE using the contact information below.

<u>The surveys will remain open through Friday, February 27, 2015</u>. It is critical for all schools to participate in each of the surveys.

#### • Georgia Student Health Survey 2.0

There are two versions of the Georgia Student Health Survey (GSHS) 2.0. The first version is for middle and high school students (grades 6 – 12), and the second version is a short survey for elementary students (grades 3-5). At least 75% of students at each grade level (3-12) must participate in the GSHS 2.0 to be eligible for the School Climate Star Rating. Please make plans for your elementary, middle and high school students to participate in the GSHS 2.0. Survey responses are anonymous and will be submitted directly to the Georgia Department of Education for analysis. The survey is offered at no cost to all Georgia public school districts and private schools that wish to participate. We will let you know soon when the Spanish version of the student survey is available. The URL addresses for the elementary, middle and high school surveys are posted below.

#### <u>Georgia School Personnel Survey</u>

The **Georgia School Personnel Survey** (GSPS) is modeled after the student survey and includes 31 questions. The GSPS is for all teachers, school administrators, certified staff members and other classified staff members (paraprofessionals, office staff, cafeteria workers, custodians, etc.) who work at least 50 percent of the day in the school. At least 75% of your teachers and administrators must participate in the survey to be eligible for the School Climate Star Rating. Most teachers should be able to participate in the GSPS using their classroom computer. The survey is also accessible using an iPad or smartphone. Survey responses are anonymous and will be submitted directly to the Georgia Department of Education for analysis. Data results from the Georgia School Personnel Survey will not be available to the public and will not be posted online. Access the survey here.

The **Georgia Parent Survey** is also modeled after the student survey and contains 24 questions. A Spanish version of the parent survey will be available soon. Parents will be able to complete the survey using their personal computers, smartphones or iPads. For parents that do not have access to the Internet, school administrators might consider scheduling dates and times to allow parents to complete the Georgia Parent Survey at school. All parents should be encouraged to participate in the Georgia Parent Survey because the data will be used to calculate the **School Climate Star Rating**. However, there is no mandatory participation rate for parents. Survey responses are anonymous and will be submitted directly to the Georgia Department of Education for analysis. Data results from the Georgia Parent Survey will not be available to the public and will not be posted online. Access the survey here.

A survey participation website has been developed to allow schools to monitor their survey participation rates. The survey participation website was emailed directly to superintendents.

Federal law requires that the student survey questions be made available for review by all interested parties; therefore, copies may be reproduced and made available to parents or other parties upon request. Copies of the Georgia Student Health Survey 2.0 questions are available <u>online</u>. Please ensure that all parents/guardians know about the Georgia Student Health Survey 2.0 and are given the option to opt out if desired.
