

FIRST CHARTER AMENDMENT FOR ATLANTA HEIGHTS CHARTER SCHOOL

This amendment to the charter for Atlanta Heights Charter School (“Amendment”) is entered into by and between Atlanta Heights Charter School, Inc. and the State Charter Schools Commission (“SCSC”) to amend the attendance zone for Atlanta Heights Charter School.

WHEREAS, Atlanta Heights Charter School, Inc. operates Atlanta Heights Charter School pursuant to a charter contract executed on or about June 9, 2022 (the “Charter Contract”);

WHEREAS, Atlanta Heights Charter School seeks to expand its attendance zone; and

WHEREAS, the SCSC believes that this charter amendment is in the best interest of the ongoing viability of the school and its service to its students and community;

NOW THEREFORE, in consideration of the promises, mutual agreements, and covenants contained herein and other good and valuable consideration, the sufficiency of which is hereby acknowledged, the Petitioner and the SCSC agree as follows:

1. Section a of Paragraph 6 of the Charter Contract shall be amended to read:

Attendance Zone. Enrollment shall be open to any grade level eligible student who resides in the Atlanta Public Schools, Clayton County School District, Cobb County School District or Fulton County School District attendance zones.

2. Except as amended herein, all other terms and conditions of the Charter Contact, including any prior amendments, shall remain in full force and effect.


