### **CARES Act Resources**

The federal Coronavirus Aid, Relief, and Economic Security (CARES) Act was signed into law by President Trump on March 27, 2020. The bill provides \$2 trillion in economic stimulus funds. Specific portions of the CARES Act that may provide relief for charter schools include:

- The Elementary and Secondary School Emergency Relief Fund (\$13.23 billion). These funds will flow directly to LEAs (including state charters) based on Title I allocations. Funds can be used for a variety of purposes including providing technology and connectivity to support online learning due to long-term school closures. Georgia's application for CARES Act funds has been approved by the U.S. Department of Education and funds will be available for schools following State Board of Education approval. - The SBOE approved the GaDOE Superintendent's recommendation to accept and allocate the K-12 CARES Act funding. The SBOE items can be found [here](#). An infographic is attached [here](#).

### **The Families First Coronavirus Response Act**

- The Families First Coronavirus Response Act (FFCRA or Act) requires certain employers to provide their employees with paid sick leave and expanded family and medical leave for specified reasons related to COVID-19. These provisions will apply from April 1, 2020 through December 31, 2020. Please visit the U.S. Department of Labor, Wage and Hour Division [website](#) for additional information and [FAQs](#). NOTE: Public employers and government entities, including state charter schools, must display [this poster](#).
- The U.S. Department of Labor ended its period of nonenforcement of the Families First Coronavirus Response Act (FFCRA), which requires certain employers to provide their employees with paid sick leave and expanded family and medical leave for specified reasons related to COVID-19. The agency provided an initial period of nonenforcement until April 20 to allow impacted stakeholders to receive guidance without penalty.

## **State Resources**

### **From the Governor's Office**

- Governor Kemp issued an [Executive Order](#) on June 29, 2020 instructing the State Board of Education to promulgate rules, regulations and guidance pertaining to the operation of public schools this fall. The executive order also extended the public health emergency through August 11.

Additionally, minimal staff can continue to report to sustain core functions/services, such as providing food services and supporting digital/distance learning efforts.

    - The Georgia Department of Public Health asks: “If you believe that you are experiencing symptoms of COVID-19 or have been exposed to the novel coronavirus, please contact your primary care doctor, an urgent care clinic, or your local federally qualified healthcare center. Please do not show up unannounced at an emergency room or health care facility.”
  - DPH issued an [order](#) for isolation for individuals with COVID-19 or those who have come into contact with them/ suspected contact.
  - DPH published an [interactive map](#) showing Public Wi-Fi locations to help those working or learning from home during COVID-19.

  - DPH revised its rules and postponed implementation of the high school meningococcal conjugate vaccine (MCV4) booster dose requirement from July 1, 2020, to July 1, 2021. Effective July 1, 2021, children 16 years of age and older, who are entering the 11th grade (including new entrants), must have received one booster dose of the meningococcal conjugate vaccine (MCV4), unless their initial dose was administered on or after their 16th birthday. This does not impact any of the other currently required immunizations or the Form 3231. DPH provided two versions of parent letters in both [English](#) and [Spanish](#) with further details.

### **Georgia Division of Family & Children Services**

To limit the spread of COVID-19 and assist families, the Division of Family and Children Services (DFCS) requests that families with school-age children be allowed and encouraged to use district-issued student devices to access SNAP (Supplemental Nutrition Assistance Program), Medicaid or TANF (Temporary Assistance for Needy Families) applications and information remotely.

To facilitate this, DFCS asks that the following websites remain unblocked on student devices:

DFCS is amending operations to ensure that they can continue to support vulnerable Georgians in this difficult time.

  - The GaDOE announced that the U.S. Ed approved an extension of its ESSA waiver. **Students assessed with the alternate assessment who earn a regular diploma will continue to count for graduation rate calculations.** Additionally, GaDOE now has permission to reassign students with the most significant cognitive disabilities who would be eligible for the State-defined alternate diploma and who remain in school – but are currently under the regular diploma policy – **to a future cohort** so that they will count toward the four-year cohort graduation rate, regardless of the year they receive their diploma – provided they graduate within the time period for which the state ensures the availability of a free appropriate public education (FAPE) for students with disabilities. In Georgia, this is when a student has reached age 22. GaDOE's accountability team will go over the details during the Cohort Withdrawal Update application webinar this summer.   - GaDOE announced that in addition to the CARES Act funding for districts, it'll be recommending supplemental funding to support students in GNETS for SBOE approval at next week's scheduled board meeting. The recommended allocations are [here](#).

- GaDOE announced that it will recommend at the June SBOE meeting an extension of blanket waivers through the 2020-2021 school year. GaDOE will be advocating for additional flexibility from requirements in state and federal statutes by working with the legislature, U.S. Ed, and congressional delegation.
  - GaDOE announced that the State Board of Education (SBOE) approved several action items and GaDOE presented several measures at its May 15 meeting.
  - They are as follows:
    - The SBOE approved the recommendation from Superintendent Woods for additional supplemental funding for GNETS programs. Click [here](#) for allocations.
    - The SBOE approved [additional statewide waivers](#) regarding reporting and training. Superintendent Woods will recommend at the June SBOE meeting that statewide waivers be extended through the 2020-2021 school year.
    - Under the Superintendent's Report, GaDOE outline the impact of the proposed 14% reduction to the agency's budget as well as strategies adopted agency-wide to adhere to these planned reductions. Click [here](#) for the presentation.

  - GaDOE announced that a preliminary 'Level of Community Spread' report developed by the Georgia Department of Public Health has been circulating. However, the county-by-county report is still being finalized -- **please hold off on using the draft report for planning and communication purposes until the finalized report is shared by GaDOE.**

Some important points:

- The plan is for these DPH reports to be released to you on a weekly basis. Superintendents will be given some lead time for planning purposes before these reports are made public.
- The preliminary report included counties labeled as “Insufficient Data”. This will be corrected in the finalized report with all counties receiving a community spread rating moving forward.
- The level of community spread your county is currently labeled at can – and likely will – change before school starts back. The report that has been shared is not the signal for the level of community spread for when school starts back. It is the signal for the level your county is at this week.

The DPH point of contact will be Sara Kroening, Deputy Chief Nurse of School Health [sara.kroening@dph.ga.gov](mailto:sara.kroening@dph.ga.gov). However, GaDOE notes for schools to continue working closely with local health departments.

- GaDOE announced that the use of AFY19 School Security Grant funds is now extended to **October 30, 2020**. Local school systems will be required to submit their reimbursement requests to GaDOE no later than **September 30th**. Additional details regarding the extension will be shared with LEAs by GaDOE’s facilities team.
- GaDOE announced that Georgia will submit a waiver to the U.S. Department of Education for the suspension of the 2020-21 Georgia Milestones assessment and CCRPI school and district rating. A joint statement from Gov. Brian Kemp and GaDOE can be read [here](#).
  - GaDOE noted that several individuals have inquired about the testing contract that was originally posted for the June 18, State Board of Education meeting. GaDOE shared the following information:
    - The *contract* is a routine item. Its ultimate approval will be needed to plan and prepare for testing for the 2020-2021 school year.
    - Testing preparation, planning, and administration is a process that occurs throughout the year. As you can imagine, a lot of planning and prep work must take place to pull off the statewide testing administration smoothly. Even though the Governor and

---

Superintendent have announced a waiver request, we must plan and prepare until we receive USED approval. We also want to provide the BEACON formative tool for free for districts for the 2020-2021 school year.

- GaDOE only pays for work done off the contract. Funds will only be pulled off the contract for work that is completed and needed, not necessarily the full amount of the contract.
- Any 'surplus' testing funds go back into the state treasury. GaDOE is not able to repurpose these 'savings' unless explicitly given that authority by the budget writers.
- GaDOE announced that in partnership with the Governor's Office, they're in discussions with the Georgia Department of Public Health to get the county-by-county reports/maps of level of community spread finalized to guide school restart efforts throughout the 2020-2021 school year.
- GaDOE announced an online survey to get the public's feedback on a waiver of the high-stakes testing requirement in the Every Student Succeeds Act (ESSA) for the 2020-2021 school year. The online survey can be found at the link [here](#) through Friday, July 10 at 11:59 p.m.
- GaDOE released an FY21 Budget update. Down from the original anticipated 14% cut to QBE, there was a 10% cut to QBE -- \$950 million. Click [here](#) to review the full budget. Enrollment growth, equalization, sparsity grants are all fully funded. Once the budget is formally adopted, GaDOE will share updated allotment sheets.

## **Assessment**

### ***Elementary & Secondary Education State Testing & Related Activities***

The following assessment activities are waived:

- State assessment window/administration (including Georgia Milestones EOGs/EOCs, GAA, and all other required testing);
- Georgia Kindergarten Inventory of Developing Skills (GKIDS) administration;
- Teacher and leader evaluation (TKES/LKES) requirements and reporting; and
- Attendance-related consequences (including CCRPI, TKES/LKES, Star Climate Rating, and make-up day requirements).

GaDOE received a [letter from Secretary DeVos](#) regarding ESSA flexibility with regard to state testing and accountability. GaDOE sought and was preliminarily granted all waivers afforded by USED. On March 27, 2020, GaDOE received [notice](#) that the waiver request was formally approved.

- The SBOE-approved waiver of the 20% EOC requirement applies to any students who complete an EOC-required course during the remainder of the 2019-2020 school year (spring/summer 2020) and were expected to participate in the EOC during the Spring or Summer 2020 EOC windows. - GaDOE announced there will be no 2020 CCRPI report since assessment requirements and many accountability requirements were waived by the U.S. Department of Education for the 2019-2020 school year. However, there are still a few data collection and reporting requirements that must be completed, including calculating graduation rates, matching available assessments for future CCRPI reports, and collecting ACCESS non-participation reasons for Title III.

To complete these requirements, GaDOE will still have the Assessment Matching, Non-Participation, Summer Graduate, and Cohort Withdrawal Update application windows this summer. Below you will find the timelines for these activities along with training webinar dates and links.

Superintendent sign-off is required for all applications. Once applications open, user guides will be provided in the CCRPI portal under CCRPI Resources.

A few additional notes:

For the first time the Non-Participation application will collect non-participation reasons for ACCESS for ELLs. This will be the only non-participation activity this year. Information collected will be used by Title III, as ACCESS participation rates are not used for CCRPI.

The Cohort Withdrawal Update application allows districts to make any needed withdrawal reason corrections, with appropriate documentation on file, to ensure the accuracy of the 2020 4-year adjusted cohort graduation rate for each of your high schools. Beginning with this year's graduation cohort, students with significant cognitive disabilities who remain in school can be reassigned to a future cohort in the application. It is critical that users participate in the training webinar prior to updating information in the application.

The Summer Graduate collection allows districts to provide updated graduation information for 12th-grade students who were reported with no withdrawal code or were reported as graduated with a Certificate of Attendance in 2020 Student Record and graduated between May 10 and August 20, 2020. Any student who completes coursework and graduates with a regular diploma over the summer without enrolling in the new school year can be counted as a graduate in the summer collection.

All application questions and issues must be resolved by the close of the application window.

## **Course Grades**

- **‘Pass/Fail’ allowed for K-8 subjects/courses**

Q: Can districts choose to assign “pass/fail” to students in grades K-8 rather than assign a numerical grade in response to school closures?

Each local board of education is required to establish 70 as the minimum passing score for all subjects/courses taught in grades 4-12. Working within those parameters, local districts may determine the requirements for content mastery, course completion, and final grades for their students.

Yes, for subjects/courses taught in grades K-8, districts may choose to issue course designations of “pass” or “fail” in lieu of final grades or numeric scores, as long as 70 is established as the minimum passing score in grades 4-8. This option is not available for high school subjects/courses, including high school subjects/courses taught in middle school for high school credit. All subjects/courses for grades 9-12, including those courses that are taught in middle school for high school credit, shall have numerical grades of students in all courses for which credit is given in those courses.

- The Georgia Student Finance Commission (GSFC) will honor district-determined grading policies for high school students. As stated in GaDOE guidance, it is a requirement that districts assign final numerical grades for all high school courses; GSFC will use those grades for GPA calculations. GSFC released [a FAQ](#) with further details.

## **TKES/LKES**

- All TKES/LKES evaluations have been suspended for the remainder of 2019-2020 school year. GaDOE and GaPSC provide additional guidance with a [FAQ](#).

### ***Post-Secondary Education Testing & Admissions***

- As College Board and ACT have suspended upcoming testing dates indefinitely, the University System of Georgia (USG) has approved a temporary adjustment to admissions criteria that will allow institutions to admit students without ACT or SAT scores. Guidance is available [here](#).
- The Technical College System of Georgia (TCSG) is suspending placement exam requirements for admission to summer and fall 2020 classes. The system is also suspending the requirement to submit a high school transcript or equivalency transcript in addition to waiving the requirement that students must submit scores on the ACCUPLACER exam.
- The Georgia Student Finance Commission released updates to the Zell Miller Scholarship. Requirements for this scholarship are set in state law. Students with SAT/ACT scores on file can meet Zell Miller Scholarship eligibility requirements; GSFC is working with SAT/ACT providers for possible options for summer testing administrations.

### ***International Baccalaureate (IB Testing)***

- The May 2020 examinations for Diploma Programme and Career-related Programme students were canceled.
- Depending on what they registered for, the student will be awarded a Diploma or a Course Certificate which reflects their standard of work. This is based on student's coursework and the established assessment expertise, rigor, and quality control already built into the programmes.

Superintendent Woods submitted another round of waiver requests to USED, including:
    - Eliminating the carryover limits for Title I, Part A (beyond 15%)
    - Extending the period of availability/use of current carryover federal funds through 2021
    - Suspending identified Title IV requirements (including the needs assessment for 2019-2020 school year, content area spending requirements, and 15% limit to purchase technology), and
    - Waiving the definition of professional development (for the 2019-2020 school year)

#### **GNETS Federal Grant Carryover Cap Lifted**

- GaDOE suspended the carryover limit for the GNETS federal grant for this year. GaDOE will allow 100% carryover for the FY20 GNETS federal grant.

#### **21st Century Carryover Cap Removed**

- GaDOE waived the annual 15% carryover percentage limitation for FY20 Title, IV, Part B – 21st Century Community Learning Centers (CCLC) subgrants. 21st CCLC subgrantees are permitted to carryover all unexpended funds from FY20 into FY21.

#### **Special Education**

- The Division for Special Education Services and Supports, is working diligently to release guidance specific to students with disabilities. Additional guidance is

- Per OSEP's guidance, if your local school system is implementing an alternate mode of instructional delivery (i.e. virtual/distance learning) for all students, then you are not required to amend the Individualized Education Programs (IEPs).
- IEP Team meetings can be held virtually, if appropriate.
- Many of you have expressed a need for flexibility based on several IDEA requirements such as timely evaluations, IEPs in place by age 3, expiring IEPs, initial IEPs, formal complaint timelines, etc. GaDOE will reach out to USED to seek any flexibility that can be provided for these areas and encourage you to focus on meeting the needs of students, teachers, and leaders.
- Discussions are being held to discuss SST questions and information will be shared as soon as possible.

  - GaDOE issued clarification on Individualized Digital Learning Plans:

Though LEAs must document the provision of FAPE and access to the curriculum for individual students with disabilities, **individualized digital learning plans for students with disabilities are not state or federally required**. There is no state or federal requirement that IEPs be amended to include an individualized digital learning plan as long as the provision of FAPE and access to the curriculum are documented. You should consider specific accommodations and services provided to students with disabilities during COVID-19 school closures and any additional LEA needs to transition to extended distance/remote learning opportunities during the upcoming school year. You must document interim **good faith efforts** to provide services, but the decision to utilize an individualized digital learning plan to meet this requirement is at the **sole discretion of local districts and IEP teams**.
  - GaDOE submitted a waiver to request an extension of the period of availability in Section 421(b) of the General Education Provisions Act for FY19 Individuals with Disabilities Education Act (IDEA) Part B grant award funds. Georgia has received approval for an extension for the FY19 IDEA Part B grant award period of availability. With this approval, the FY19 IDEA 611 and 619 funds will be available for obligation through **September 30, 2021**.

All Local Educational Agencies (LEAs) will continue to receive 100% carryover for these grants, and no further action is needed. LEAs who received an IDEA Capacity Building Grant in FY20 will receive 100% carryover of those funds. ## **School Nutrition**

GaDOE received word from the U.S. Department of Agriculture (USDA) that two waivers have been approved to extend alternate meal service flexibility in the case of extended closures due to COVID-19.

This will allow schools to serve students' meals through USDA-approved meal service options, at state-approved sites within the community. Local students can go to open area sites to receive meals. Meal sites operating under this waiver will not be closed to children age 18 and under. GaDOE has advised that the emergency nutrition programs offered by districts need to be "open" (like a summer school programs) meaning any student that resides in the local district can receive meals. State charters that offer nutrition programs are also eligible to implement a program with the approval of GaDOE.

*Employee Safety Guidance for School Nutrition Programs During COVID-19 Pandemic* is being sent to all school nutrition directors.

GaDOE also issued a *School Nutrition Program FAQ document*.

Due to a recently awarded USDA waiver, Georgia can now allow local SFA's to submit their plan to manage pick up of meals by parents and/or guardians without the presence of children, based on specific criteria. GaDOE is finalizing the development of an application model (a requirement of USDA). The application, along with detailed guidance, will be shared with districts soon.

## **School Facilities**

## School Finance

The Georgia Department of Education Financial Review Division compiled a [FAQ document](#) to address common questions related to the current COVID-19 health crisis.

Among the questions was, “Will the budget requirements set forth in O.C.G.A. §20-2-167(a)(5) and §20-2-167.1 be waived for FY 2021?” In response, the GaDOE states that “[t]he requirements to adopt a balanced budget in order to operate are still in effect.” Further, according to the [FAQ document](#) state charter schools must follow the budget requirements set forth in O.C.G.A. §20- 2-167(a)(5) and §20-2-167.1.

Notably, O.C.G.A. §20-2-167.1 requires the governing boards for state charter schools to “hold at least two public meetings, which shall not occur within the same week, for the purpose of providing an opportunity for public input on its proposed annual operating budget before adopting any budget.”

State charter schools may “pass a Budget Resolution for each month in FY 2021 until a balanced budget is adopted. The GaDOE Financial Management Handbook for Georgia’s Local Units of Administration (FMGLUA), Section IV – Chapter 2, includes details on passing a Budget Resolution for each month of the fiscal year until an annual budget is adopted. Please see full [chapter here](#).

## Annual Budget Hearing Guidance

- 1. Are governing boards required to hold at least two public meetings for proposed amendments to state charter school FY20 annual operating budgets?**

Yes. Consistent with [guidance](#) issued by the Georgia Department of Education (GaDOE), governing boards must hold at least two public meetings on the

---

school's annual operating budget. As expressed in the SCSC [Legal Obligations Guidance](#), the requirement to hold public hearings on the school's annual budget also applies to budget amendments. Thus, if a school's governing board proposes to amend its FY20 budget, it must do so consistent with the notice requirements in O.C.G.A. § 20-2-167.1.

**2. Can governing boards hold FY20 annual budget amendment hearings virtually given Executive Orders responsive to the Coronavirus (COVID-19) pandemic?**

Generally, the SCSC interprets the requirements of O.C.G.A. § 20-2-167.1. consistent with those of the Georgia Open Meetings Act. Except in the case of certain schools with state-wide attendance zones, the language of the provision contemplates, but does not explicitly state, that annual budget hearings occur in-person. The SCSC has previously required annual budget hearings or amendments to be conducted via in-person public meetings. However, given the public health emergency, should a governing board determine that emergency circumstances exist as defined by the Georgia Open Meetings Act, O.C.G.A. § 50-14-1 (d) and (g), the SCSC will conclude that a governing board that holds the two public hearings virtually has met its legal obligations; provided, it gives an opportunity for public feedback on the budget and meets all notice requirements under O.C.G.A. § 20-2-167.1 and the Georgia Open Meetings Act.

*State charter schools are encouraged to consult with independent legal counsel should they wish to proceed with virtual budget amendment hearings during the state of emergency. Although the SCSC may consider a virtual hearing compliant for accountability purposes, there may be a need to evaluate the possibility of additional risks outside of the SCSC accountability context.*

**3. Given that the State of Georgia has not passed an FY21 budget, are governing boards still required to adopt an FY21 annual operating budget?**

Yes. However, because the State of Georgia does not have an approved FY21 budget, GaDOE is unable to provide FY21 QBE estimates to state charter schools. Thus, state charter schools will likely experience difficulty developing an accurate FY21 budget. If the state charter school is unable to develop and pass its FY21 budget by June 30, 2020, the state charter schools MUST pass a spending resolution each month in FY21 until the state charter school is able to

---

adopt an FY21 budget. Section IV – Chapter 2 of the GaDOE Financial Management Handbook for Georgia’s Local Units of Administration (FMGLUA) includes details on passing monthly spending resolutions as well as sample spending resolutions. You may access the full chapter [here](#). Pages IV-32-54 through IV-32-55 discuss spending resolutions specifically.

The SCSC does not equate the adoption of a spending resolution with an “annual operating budget” as governed by O.C.G.A. § 20-2-167.1. Because the adoption of a spending resolution requires board approval, any vote to adopt a spending resolution must comply with the requirements of the Georgia Open Meetings Act.

**4. Once the State of Georgia approves an FY21 State budget, will the SCSC continue to find that governing boards holding virtual budget hearings have met O.C.G.A. § 20-2-167.1 legal obligations?**

Whether the SCSC may consider virtual FY21 annual budget hearings compliant with O.C.G.A. § 20-2-167.1 will depend on whether a governing board has appropriately determined that a state of emergency, pursuant to Georgia Open Meetings Act provisions at O.C.G.A. § 50-14-1 (d) and (g), exists. Governing boards should consult with independent legal counsel in making this determination and are further encouraged to contact SCSC legal staff for additional guidance before planning to hold an FY21 annual budget hearing virtually.

**5. Are there any recommendations for how state charter schools should plan for FY21 annual budgets?**

The SCSC cannot predict when an FY21 budget will be approved or the exact impact of the Coronavirus (COVID-19) pandemic on the education funding formula. The SCSC has not received any formal communication regarding changes to the FY21 education funding formula. Thus, the SCSC recommends

---

that schools continue plans to prepare a contingency budget for FY21 using the school's 65% projected enrollment operating budget as a starting point.

### **Vendor Agreements**

Many state charter schools may have vendor contracts that will be impacted by COVID-19.

- As a preliminary matter, state charter schools should conduct an analysis of vendor contracts to identify which partnerships may be affected.
- Once impacted contracts are identified, state charter schools should review each contract to gauge the potential impact of deferring or terminating the contract.
  - Many contracts will contain “Force Majeure” or “Acts of God” clauses
    - O.C.G.A. § 13-4-21. Effect of an Act of God. “If performance of the terms of a contract becomes impossible as a result of an act of God, such impossibility shall excuse nonperformance, except where, by proper prudence, such impossibility might have been avoided by the promisor.”
- Schools should work closely with their attorney to address contracts which may present a termination or deferral risk.

### **Governing Board Meetings**

- The Open Meetings Act provides flexibility in “emergency circumstances,” which must be determined by the school. The Open Meetings Act permits governing bodies to conduct meetings by teleconference in emergency circumstances (i.e. circumstances necessitated by emergency conditions involving public safety or the preservation of property or public services, agencies or committees) “so long

as the [required notice] is provided and means are afforded for the public to have simultaneous access to the teleconference meeting.”

If the school determines that emergency circumstances exist, then the board is permitted to meet by teleconference. Although the standard notice requirements apply, governing boards may wish to follow some combination of notice procedures for regular, called, and emergency meetings to ensure that the public is aware of the change from in-person to virtual and that the meeting is still occurring. Additionally, governing boards should ensure that capacity limits for virtual meeting platforms are not prohibitive.

Further, a recording of the meeting is insufficient to allow “simultaneous access.” A School may, however, wish to make a recording available in addition to the simultaneous access required by statute. For additional information, see O.C.G.A. sec. 50-14-1 (d) and O.C.G.A. sec. 50-14-1 (g).
