Georgia Milestones Assessment Monitoring

As announced at the March SCSC meeting, the Governor's Office of Student Achievement has asked the SCSC to assist with Georgia Milestones Assessment monitoring in state charter schools this year. As a result, the SCSC will randomly monitor schools throughout testing administration. Please be assured that monitoring is a precautionary procedure that all schools are subject to in any given year. The monitor's presence at the school will not be disruptive to the testing environment or an inconvenience to staff. Please contact SCSC staff if you have any questions.

Georgia Milestones Assessment Updates from the GaDOE

The GaDOE has shared several important updates and considerations regarding Georgia Milestones. Please note that each of these is important for successful test administrations and apply to both the End of Grade as well as End of Course administrations. However, the first item listed is extremely critical. Please see below:

Critical Update for [Paper/Pencil Administrations](#)

Test Form Code on Student Answer Documents (Paper/Pencil)

For both our current End of Grade (EOG) and the upcoming End of Course (EOC) measures, please be aware that it is **critical** that each student's paper/pencil answer document has the correct form coded. Given the differences in the structure of our new assessment system versus our previous testing programs, **failure to code the test form will cause a significant delay in scoring.**

Please remember that it is no longer the case that we have the same base test form for all students. In previous years, scoring was able to continue because all students took the same base form. Because this is no longer the case, failure to code the test form will stop – completely – the scoring process for an entire school until the form can be identified and coded by CTB. This will require CTB's outreach to you, the System Test Coordinator, during processing. This is not a trivial task given the number of documents to be processed.

Below are some specific steps to take in this regard:

- As you receive scoreable materials from each of your schools, **please check each student's answer document to ensure the form is coded correctly.** (Unfortunately, our state has a long and rich history with test form coding omissions.)
- Each school has been provided a School Security Checklist (paper and electronic). To help facilitate the process, we ask that schools complete the checklist, indicating the name of the student next to each test booklet bar code. In the column labeled 'REC'D (BLC Only)' schools can record the form assigned to each student (note that recording the form assigned to each student is not required but strongly suggested; it is critical that the student name be recorded next to the booklet bar code).
- **Please include a copy of the completed School Security Checklist in Box 1 of scoreable materials for each school,** along with the School Group List. Please retain a copy of all School Security Checklists for your records.

Important Considerations for Online Administrations

Access Codes

- While Access Codes can be changed at the local level, we strongly advise that schools use the Access Code provided by CTB through the TAS.
- Access Codes cannot exceed ten (10) characters. Access Codes in excess of 10 characters will result in students being unable to connect (471 Error), requiring a call to Customer Service for resolution and resulting in a delay.

Assigning the Screen Reader

- It is necessary to click "Allow Screen Reader" in *Student Management/Edit Student* **BEFORE** assigning the designated Screen Reader test form.
- If this order is not followed, the assignment of the designated Screen Reader form will not be saved as intended for student use.

Preventing English Language Arts (ELA) Section 3 from "Timing Out"

- During the first two weeks of the EOG state testing window, we have had reports of students' sessions timing out during ELA Section 3.
- The cause of these instances appears to be that, while drafting and planning, some students are not interacting with the computer.
- As is standard protocol in the test delivery system, student tests are set to time-out after 20 minutes of inactivity as a test security measure.
- We suggest that Examiners monitor students proactively and gently remind a student, as needed, to move their mouse periodically to prevent this from occurring.

Resetting Student Test Sessions

- As discussed in our School and System Test Coordinator's Manuals, student status during online testing can be reset locally.

Since the Equity Plan is part of the annual LEA Title II, Part A plan, it must be based on the completion of an annual needs assessment.

Federal Grant Asset Distribution Opportunity State Charter Schools Commission of Georgia

The SCSC on behalf of the Georgia Department of Education (GaDOE) must redistribute assets purchased by Heritage Preparatory Academy Charter School using federal Charter School Program (CSP) grant funding following the school's closure at the conclusion of the 2014 Fiscal Year. Charter schools that are operating in Georgia in the 2014-2015 school year or have a charter approved by the State Board of Education to operate in the 2015-2016 school year by the application deadline may apply to receive, at no cost, furniture and equipment previously used by Heritage Preparatory Academy Charter School. CharterLeader Summer Bootcamp Georgia Charter Schools Association

The Georgia Charter Schools Association's (GCSA) CharterLeader program is pleased to announce the CharterLeader "boot camp" which will run from Monday, June 15-Thursday, June 18, 2015. This intensive training will equip current and aspiring leaders in charter schools to develop the skills and core competencies to launch, lead, convert, replicate, and/or expand high quality schools. This is the perfect opportunity for any school administrator or teacher leader to earn 10 Professional Learning Units (PLUs) which will be needed for certification renewal.

This CharterLeader program is unique in the nation, offering charter-specific training to help build a leadership pipeline for Georgia. Modules covered in CharterLeader include: Leadership Assessment, Overview, and Best Practices; Establishing School Culture; Teacher Retention and Induction; School Funding & Budgeting; Professional Standards Commission Requirements; Effective Hiring Practices; Leader Keys and Teacher Keys Effectiveness System; Code of Ethics; School Improvement; Professional Development Planning; Governance, Risk Management, and Strategic Planning; Waivers; Legislative Rule update.

Candidates are expected to attend and participate in all cohort meetings and trainings.
