SCSC Meetings

The last monthly State Charter Schools Commission was held on July 29, 2015. The meeting minutes are available <u>here</u>. The next Commission meeting is scheduled for Wednesday, August 26, 2015 at 10:00 a.m. in the Department of Early Care and Learning (DECAL) Board Room. SCSC Performance Framework

The SCSC has developed a **comprehensive performance framework** to serve as the **primary accountability tool** for assessing **academic, financial, and operational performance of state charter schools**. The performance framework was the chief recommendation of a National Association of Charter School Authorizers (NACSA) evaluation of SCSC policies and practices, undertaken to assist the SCSC in continually improving and refining its authorizing practices. The goal of the performance framework is to increase transparency and objectivity by clarifying SCSC accountability expectations and by providing schools with an annual assessment of where they stand in terms of charter renewal. Specifically, the performance framework clearly defines and establishes the SCSC's expectations for:

- Academic Performance on both achievement and growth,
- Financial Performance in terms of near-term viability and long-term sustainability, and
- Organizational Performance in critical areas such as governance and legal compliance.

The performance framework is posted for review on the <u>Comprehensive Performance Framework page</u> of the SCSC website. More information, including steps for providing feedback, frequently asked questions, and the adoption timeline, are all available, as well.

SCSC Financial Best Practices Meeting

The SCSC will host a virtual meeting to discuss financial best practices for schools on August 24, 2015. SCSC school leaders, Chief Financial Officers, and business managers are invited and encouraged to participate.

Guest speakers will share helpful guidance and school representatives will have an opportunity to ask questions and network information among peers. SCSC staff will also discuss financial expectations of state charter schools and highlight important due dates for items that will impact school accountability.

TKES/LKES Credentialing Training

August 25 -28 Utopian Academy for the Arts 6630 Camp Street, Riverdale, Georgia 30327 9:00 a.m. to 4:00 p.m. each day

This training session will provide initial training and credentialing for new personnel at new and existing state charter schools. State charters should send the individuals from their schools who will be charged with conducting TKES/LKES evaluations to this training. The SCSC recommends that at least two individuals become credentialed to conduct TKES evaluations (evaluations of teachers) and that two individuals become credentialed to conduct LKES evaluations (evaluations of school leaders). Generally, school administrators are charged with conducting TKES/LKES evaluations, and the principal and a board member are charged with conducting LKES evaluations. The SCSC has created a TKES/LKES guidance document for state charters that may address your questions, available <u>here</u>.

Governance Training

Georgia law, O.C.G.A. § 20-2-2084(f), requires every member of a governing board of a state charter school to participate in annual governing board training. For FY16, state charter school governing board members may fulfill this obligation by one of two methods.

- 1. State charter school governing board members may attend one of the two governing board training opportunities provided to state charters by the SCSC *at no charge*; or
- 2. State charter school governing board members <u>may use their own funds</u> to contract for a minimum of 12 contact hours of training from a provider that is approved by the State Board of Education to deliver governance training to charter schools. Training content must reflect the topics covered at the SCSC Governance Training. Review the <u>SCSC Guidance on Governance Training</u> for a complete list of requirements and to ensure compliance.

The SCSC strongly encourages state charter school governing board members to attend one of the governance trainings conducted by the SCSC as these trainings provide board members the unique opportunity to discuss issues and concerns

directly with their authorizer. Further, the SCSC staff's unique understanding of the compliance issues facing state charter schools ensures that SCSC training sessions are always topical, relevant, and timely.

2015 CCRPI Summer Graduate Collection

The 2015 Summer Graduate Collection is now open *(earlier than expected)* behind the Georgia Department of Education (GaDOE) secure portal for district users. The window for the Summer Graduate Collection will close **August 28, 2015.**

Georgia collects summer graduates and will include these graduates, as appropriate, in the 4-year and 5-year cohort graduation rates. Summer graduates are defined as 12^{th} graders who remained active at the close of the 2015 Student Record (SR) or received a Certificate of Attendance and now qualify for a General diploma (i.e. Diploma Type = G).

District personnel designated to complete this activity are asked to refer to the guidelines for the collection of the summer graduates outlined below.

- 1. Data collected in this application will be used for the 2014 five-year extended cohort graduation rate and for the 2015 four-year cohort graduation rate.
- 2. Summer graduates must be reported in the Summer Graduate data collection in the GaDOE portal **and** in the FY2016 FTE Collection Cycle 1.
- 3. The withdrawal date of summer graduates must fall between May 13, 2015 and August 21, 2015.
- 4. The 2015 Summer Graduate Collection Application User Guide is attached to this email.
- 5. Superintendents must sign off to complete the process.

The application can be accessed by district level users by logging into the MyGaDOE portal, hovering over the CCRPI link, and clicking on Summer Graduates.

Suicide Prevention Training and Model Policy

On May 5, 2015, Governor Deal signed House Bill 198 (Jason Flatt Act--Georgia) into law. The new law requires teachers, counselors, and other certified public school personnel to have annual suicide prevention training. <u>The law also requires</u> each school district to adopt a policy on suicide prevention.

Training opportunities will be provided by representatives from the Georgia Department of Education, the Georgia Department of Behavioral Health and Developmental Disabilities, and the Society for the Prevention of Teen Suicide during *Suicide Prevention Week* in September 2015. Each school system has the opportunity to register a team of up to five people to receive suicide prevention training. The team members will be expected to return to their school system and redeliver the information. Please use the registration link provided below to select the training session date and time that works best for your team. The teams should include counselors, social workers, nurses and/or other personnel that will be responsible for redelivering the information to your school system personnel. <u>School systems that already have a suicide prevention program in place are not required to attend the training.</u>
