State charter school board members and administrators are required by law to attend the SCSC School Governance Training. Topics will include the roles and responsibilities of school board members and administrators, ethics, school funding and budgets, audit requirements, strategic planning and succession planning, among others. The SCSC will reimburse travel expenses in accordance with state guidelines.

Charter Schools Financial Management Certification Program

Introductory Accounting February 25-27, 2014 Atlanta, Georgia

Invited: School Business Managers and Administrators

The SCSC will offer a full scholarship to state charter business managers and/or administrators who wish to enroll in the Carl Vinson Institute of Government's Charter Schools Financial Management Certification Program. Courses must be completed within a three-year period. The Introductory Accounting course will introduce participants to basic accounting concepts for governmental funds. Topics covered include – accounting equation, chart of accounts, double entry accounting, accounting systems and records, fund accounting, basis of accounting, payroll and benefit accounting, and case study. SCSC Releases Charter School Lottery Guidance

Just in time for the upcoming enrollment season, SCSC staff released guidance describing the best practices for conducting charter school student enrollment lotteries. The guidance explains important requirements of law, rules, and SCSC expectations. Moreover, the guidance discusses how to conduct a student enrollment lottery, using enrollment priorities, maintaining wait lists, and student enrollment after the lottery. GaDOE Charter Schools and Charter Systems Annual Report

The GaDOE District Flexibility and Charter Schools Division 2014 Annual Report is available here. The report is an overview of Georgia's charter schools and charter systems, compiled by consolidating data from each charter school and charter system report, along with academic assessment data. The report is prepared annually for the Georgia General Assembly on behalf of the State Board of Education, as a requirement of law.

Affordable Care Act Requirements

Reporting requirements related to the Affordable Care Act under Internal Revenue Code Sections 6055 and 6056 go into effect for calendar year 2015. Employers with 50 or more full-time employees (including full-time equivalent employees) will use **DRAFT** Forms 1094-C and 1095-C (located at www.IRS.gov/draftforms) to report the information required regarding offers of health coverage and enrollment in health coverage for their employees.

One aspect to consider regarding the reporting requirements for **DRAFT** Form 1094-C is how a district will document the hours worked of employees that currently are not offered health insurance. For example, if substitutes are paid based on days worked instead of hours worked, the district will need to consider how those days worked will be converted to hours worked to determine eligibility for health insurance coverage.

Due to the reporting requirements, GaDOE recommends using an hourly rate when feasible to capture the activity of various employees. However, if an hourly rate is not practical, please understand that a conversion process to report eligibility to the IRS will be necessary.

For PC Genesis users, GaDOE PC Genesis group released instructions on September 30, 2014 for the *Print Balance Sheets* (*After Updates*) *Export Option*. These instructions addressed a work around for calculating an hourly rate based on the daily rate for various groups of employees. For your convenience, these instructions will be released by GaDOE with the PC Genesis updates on December 30, 2014. If your district operates on a financial system other than PC Genesis, please ensure the software vendor offers the capability to capture the hours worked for 2015.

DRAFT Form 1095-C, Part III, requests information for each employee and covered individuals. The GaDOE is requesting information from the State Health Benefit Plan to determine what reports can be provided to meet the covered dependent reporting requirements of **DRAFT** Form 1095-C, Part III.

If you provide health insurance outside of the State Health Benefit Plan, please consult with your provider to determine how this information will be captured and reported.

GaDOE will provide updates regarding these reporting requirements as information becomes available. If your district has specific questions related to these federal requirements, please contact your school district attorney.

HiQ Data Release

The HiQ data for 2015 will be released by GaDOE on Friday evening, January 16, 2015. GaDOE has emailed important and helpful guidance to assist LEA personnel in verifying and signing off on the accuracy of the 2015 HiQ data. Included in the document is guidance for the following:

- Ensuring Access to the HiQ Data System for LEA Personnel
- Verifying the Accuracy of the HiQ Data for 2015
- Editing Records to Correct Inaccurately Reported Assignments
- The Principal and Superintendent HiQ Data Approval Process

Principals and superintendents will be required to sign off on the HiQ Data. It will be up to the Title II, Part A LEA Coordinator to determine when (on or after May 1, 2015) to release data to principals and superintendents. Your data release to principals gives principals read-only access to their specific building-level HiQ percentage data, as well as to their list of teachers and paraprofessionals and assignments. Not only does this enable the Title II, Part A LEA Coordinator to make any additional corrections, but this also completes each principal's HiQ data verification for the year. Once you release your data to your principals, you will be able to see, at any time, the status of the sign-offs.

Superintendents may sign off prior to the closing of HiQ (June 30, 2015), if they choose. However, they must sign off no later than August 31, 2015. GaDOE recommends coordinators request that principals sign off on their building level data by June 15, 2015, in case the superintendent chooses to sign off prior to the HiQ closing. Please note that the HiQ system will close at midnight on June 30, 2015. No edits can be made after that date.

GaDOE School Climate Survey

School climate surveys for the 2014-2015 school year are now available. Data from the **Georgia Student Health Survey** 2.0, the **Georgia School Personnel Survey** and the **Georgia Parent Survey**, along with other sources, will be used in the calculation of a **School Climate Star Rating** which is a diagnostic tool within the CCRPI. Each of the surveys is administered online through the provided URL address. As soon as the school administrator enters the URL address into the web browser, a drop-down menu will appear and the school administrator will use the drop-down menu to select their school district and their school. If there are new schools that wish to participate that are not included in the drop-down menu, please contact GaDOE using the contact information below.

<u>The surveys will remain open through Friday, February 27, 2015</u>. It is critical for all schools to participate in each of the surveys.

• Georgia Student Health Survey 2.0

There are two versions of the Georgia Student Health Survey (GSHS) 2.0. The first version is for middle and high school students (grades 6-12), and the second version is a short survey for elementary students (grades 3-5). At least 75% of students at each grade level (3-12) must participate in the GSHS 2.0 to be eligible for the School Climate Star Rating. Please make plans for your elementary, middle and high school students to participate in the GSHS 2.0. Survey responses are anonymous and will be submitted directly to the Georgia Department of Education for analysis. The survey is offered at no cost to all Georgia public school districts and private schools that wish to participate. We will let you know soon when the Spanish version of the student survey is available. The URL addresses for the elementary, middle and high school surveys are posted below.

Georgia School Personnel Survey

The Georgia School Personnel Survey (GSPS) is modeled after the student survey and includes 31 questions. The GSPS is for all teachers, school administrators, certified staff members and other classified staff members (paraprofessionals, office staff, cafeteria workers, custodians, etc.) who work at least 50 percent of the day in the school. At least 75% of your teachers and administrators must participate in the survey to be eligible for the School Climate Star Rating. Most teachers should be able to participate in the GSPS using their classroom computer. The survey is also accessible using an iPad or smartphone. Survey responses are anonymous and will be submitted directly to the Georgia Department of Education for analysis. Data results from the Georgia School Personnel Survey will not be available to the public and will not be posted online. Access the survey here.

• Georgia Parent Survey

The **Georgia Parent Survey** is also modeled after the student survey and contains 24 questions. A Spanish version of the parent survey will be available soon. Parents will be able to complete the survey using their personal computers, smartphones or iPads. For parents that do not have access to the Internet, school administrators might consider scheduling dates and times to allow parents to complete the Georgia Parent Survey at school. All parents should be encouraged to participate in the Georgia Parent Survey because the data will be used to calculate the **School Climate Star Rating**. However, there is no mandatory participation rate for parents. Survey responses are anonymous and will be submitted directly to the Georgia Department of Education for analysis. Data results from the Georgia Parent Survey will not be available to the public and will not be posted online. Access the survey here.

A survey participation website has been developed to allow schools to monitor their survey participation rates. The survey participation website was emailed directly to superintendents.

Federal law requires that the student survey questions be made available for review by all interested parties; therefore, copies may be reproduced and made available to parents or other parties upon request. Copies of the Georgia Student Health Survey 2.0 questions are available <u>online</u>. Please ensure that all parents/guardians know about the Georgia Student Health Survey 2.0 and are given the option to opt out if desired.
