#### **TKES/LKES TRAINING FOR NEW CHARTERS**

#### **STRATEGIC PLANNING WITH THE GOVERNING BOARD**

##### ***Individualized sessions with schools***

A facilitator from the Carl Vinson Institute of Government will provide a one-day strategic planning retreat for individual state charter school boards and assist the board in developing an executable strategic plan that specifically meets the school's individual needs. #### **FINANCIAL SYSTEM REVIEW**

##### ***Individual session with school leadership***

Elisa Falco from the Georgia Charter Schools Association will work with the school leader and financial management team to conduct an in-depth financial system review. The review will assist schools in establishing or improving effective internal controls, implementing best practices for accounting practices and procedures, and will provide schools with an assessment of fiscal health. The two-part review includes an in-depth analysis of internal controls and of the school budget.
