

SCSC Mock Interview Program

Introduction

The purpose of the SCSC Mock Interview Program is to make applicants aware of SCSC Interview expectations. Applicants may request to participate in the program by submitting the attached by email to Morgan.felts@scsc.georgia.gov.

If selected, applicants will participate in a mock interview with 2-3 SCSC staff members at SCSC offices. Interviews will take place on Tuesdays between January 10th and March 14th. Mock interviews are scheduled on a first-come, first-serve basis. The SCSC will make every effort to accommodate scheduling requests, but SCSC staff cannot guarantee availability for a specific date. Groups may only participate in one mock interview per cycle.

Mock interviews will last approximately 60 minutes. SCSC staff will not review any documents associated with your petition prior to the mock interview. Mock interview questions will include standard interview questions as well as specific questions which may stem from answers you give during the interview.

Following the interview, applicants will be asked to take a short break while the SCSC staff collects feedback. SCSC staff will then provide feedback to the applicants and allow for questions. All interviews will be recorded and applicants may request a copy of the recording be provided to them. Applicant questions must be based on the interview and understanding how a question could have been better addressed. SCSC staff will not answer questions regarding substantive portions of your petition.

Eligibility

To be eligible to participate in a mock interview, the school must satisfy all of the following:

- Applicants must have previously attended a 2016-17 SCSC Petitioner Bootcamp;
- Applicants must have at least 3 board members available to participate; and
- Applicants must have established a Georgia nonprofit* and otherwise be an eligible charter school applicant in accordance with O.C.G.A 20-2-2065.
